#### CALL TO ORDER/PLEDGE OF ALLEGIANCE

Chairman Marco called the meeting order at 7:00 p.m., and then asked everyone to join him in the Pledge of Allegiance.

President Rose stated Pursuant to the Open Public Meetings Act, notice of this meeting was given in the annual meeting notice, which was emailed to the Herald News, The Record, the Office of the County Clerk, the college community, and posted on the PCCC Website and bulletin boards on November 19, 2020.

The public may participate in this meeting only during the public portion, which takes place near the end of the meeting. To be recognized to speak, members of the public who are attending on Zoom via the web should use the raise hand function. Upon recognition by the chair, you will unmute your microphone/video. Members of the public who are attending the meeting via phone call must hit \*9 on their phone keypad to raise their hand to be recognized. Upon recognition by the Chair, they can unmute/mute their audio by using \*6 on their phone keypad. Individuals addressing the board must give their name and address in an audible tone and will have five (5) minutes to make their statement.

Comments from the public which are provided by email or written letter will be read aloud during the meeting in a manner audible to all meeting participants and the public. #### **PRESENTATIONS**

#### .Phi Theta Kappa (PTK) A Year in Review for the Chapter

He reminded everyone that the group had done so well that their presentations had to be split between two board meetings, this being the second part with their Year in Review. He then turned his attention to Professor Jennifer Gasparino, Associate Professor, Human Services and PTK Advisor.

PTK Members present that evening for the presentation were Ravyn John, Issac Belgrave, Jay Marie Martinez, Bianca Osma, Edwin Lotero, Samantha Chang, Ashely Diaz, Jenny Garcia, and Andy Perales. The topics for their presentation centered on outstanding accomplishments throughout the year both nationally and internationally. Through a PowerPoint presentation, each member of that group took turns explaining and presenting their process and planning for each program, including creating a virtual environment during the pandemic entitled, "the Virtual Center for Leadership Excellence (V-CLE)." They continued with explaining the various social media sites they use, leadership training and development, chapter planning, and fundraising efforts, to name a few. Other outstanding accomplishments included awards in Regional, Individual, Most Distinguished Chapter, College Administrator (Nancy Silvestro), and advisors (Andy Perales, Jennifer Gasparino).

President Rose reported on the Statement of Revenue and Expenditures. He once again stated that this year has been like no other, and due to additional funding by the government, the College was doing well this year despite the drop in enrollment.

He noted that many of the area high schools have lost contact with at least 30% of their enrollments. The College was currently working with Passaic High School to help its students graduate by offering the ability to earn a GED. President Rose stated that the pandemic has done a lot of damage and its effects would be with us all for years to come as we recover from it.

President Rose asked Mr. Michael A. Cerone, Jr., College Counsel, if any further explanation was needed with the changes to the various board policies presented that evening on Second Reading. He stated no, explaining that the reasoning behind the changes was discussed at last month's meeting. The following explanations are stated once again since many of the policies had outdated statutes and/or conflicting requirements that applied to different parts of the college community.

A906 was a new policy created that would cover the Drug Free Schools and Communities Act (DFSCA) and was separated from the current B109.

B109 was revised to implement a policy that just covers college employees under the Drug Free Workplace Act (DFWA).

B201 was revised to change an obsolete administrative code not renewed by the Secretary of Higher Education and renamed since multi-year contracts were never given to college employees since its existence.

E905 was revised to exclude the procedures outlined as part of the policy since that restricted the administration from effectively taken care of mental health crises as they arise.

#### D. PERSONNEL ITEMS

The personnel items included Separations, Appointments, Reappointment of Faculty - FY 2021-22. Faculty Promotion, and Part-time Temporary Appointments.

At this time, Chairman Marco stated that an individual requested that a discussion of her personnel status take place in public.

President Rose stated that Professor Cecily McKeown preferred her non-reappointment be discussed in public rather that in executive session. He went on to describe the tenure process

for faculty, noting it was a six-year process, which includes annual evaluation by the Faculty Review Committee, which is made up of tenured faculty at the College. Not all of them make it through the process. He emphasized that a faculty member did not necessarily do anything wrong, but instead did not meet the expected level of excellence. The evaluation process goes on for six years and those who successfully complete the process are given a lifetime appointment. The Faculty Review Committee has high standards and takes their responsibility seriously.

Dr. Jacqueline Kineavy, Senior Vice President for Academic and Student Affairs, and Dr. Bassel Stassis, Senior Dean for Academic Affairs, reiterated what the President said and based on the Faculty Review Committee's decision, forwarded the recommendation to non-reappoint Professor Cecily McKeown to the President.

Professor McKeown, of the Graphic Design program, which is part of the Computer Information Sciences Department, stated her case before the Board citing many challenging work-related and personal matters affecting her life. She felt strongly she was mistreated and not given the proper guidance to succeed in her position.

She was again reminded of the faculty review process and how it was based on evaluations by students, peers, and appropriate administrators over a period of time. These evaluations are sent to the Faculty Review Committee for its review and ultimate recommendation to the Senior Vice President for Academic and Student Affairs.

#### **EXECUTIVE SESSION**

Chairman Marco asked if there was a need for an executive session. President Rose stated that an executive session was needed. Hearing that, a motion to go into executive session at 8:04 p.m. was moved by Vice Chairwoman Tanis, and seconded by Trustee Glovin. Upon roll call, Resolution #2 passed with members presented voting "yes."

Chairman Marco stated that the Board would meet in executive session for approximately 20 minutes to discuss personnel, contract matters, and matters protected by attorney-client privilege; no action would be taken in executive session.
